Since the conflict in the Galvan Valley, broadening and generalizing India's security dilemma with China has become a prominent feature of India's China policy. India's response to the security dilemma is building its strength to counter China. It promotes the New India strategy and the Indo-Pacific Ocean Initiative, strengthens its economic strength and military capacity building, and builds closer relations with neighboring countries and the US-Japan-India-Australia Quadrilateral Security Dialogue. India's security dilemma with China will persist, leading to a two-track approach to India's China policy.

A new normal in China-EU economic and trade relations is taking shape as the EU adopts a series of legislation that largely target Chinese enterprises, entities and China-related supply chains. Aimed at boosting the EU's industrial competitiveness and rife with political and ideological considerations, the measures are part of the European efforts to address major-power economic competition. The legislation will pose challenges to China-EU trade and negatively impact China's national security, industrial development, and technological innovation.

142 The Weaponization of Global Financial Public Goods

Western countries use financial public goods as a weapon to impose financial sanctions on geopolitical rivals. Globalization facilitates the weaponization of global public goods because countries are highly dependent on the financial public goods provided by Western governments. The United States has urged other Western countries to pick sides to achieve its monopoly over global financial public goods. However, such weaponization cannot last.

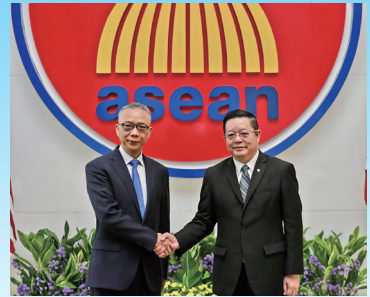

CIIS President Talks with Senior Officials and Think Tank Experts during Asia-Pacific Visit

From June 13 to 19, CIIS President Xu Bu led a delegation to visit Thailand, Malaysia, and Indonesia and had extensive communication with senior officials and experts from the Ministry of Foreign Affairs of Thailand, the Chulalongkorn University, the International Institute for Trade and Development of Thailand, University of Malaya, Association of Belt and Road Malaysia, Institute of Strategic and International Studies (ISIS) Malaysia, Ministry for Maritime Affairs and Investment of Indonesia, the China-Indonesia High-Level Dialogue Cooperation Mechanism, the Centre for Strategic and International Studies (CSIS) in Jakarta, and the Association of Southeast Asian Nations (ASEAN).



This year marks the 10th anniversary of President Xi Jinping's Belt and Road Initiative. The Belt and Road cooperation has achieved fruitful results in Thailand, Malaysia, and Indonesia. CIIS President Xu said high-quality collaboration in economy and trade, infrastructure construction, and other areas brings tangible benefits to China and the ASEAN countries. Countries in the Asia-Pacific region should eliminate the interference of extraterritorial forces and focus on economic and trade cooperation to improve social well-being.

In Xu's meeting with Dr. Kao Kim Hourn, Secretary-General of ASEAN, Dr. Kao highly valued China as the most dynamic and fruitful strategic partner in ASEAN's external cooperation. China and ASEAN have broad prospects for practical cooperation to implement the Global Development Initiative, the Global Security Initiative, and the Global Civilization Initiative.
