#### ABSTRACTS OF SELECTED ARTICLES

##### **Fiscal Multipliers under Open Economy: Based on Multi-sector DSGE Model Analysis Including Input and Output Framework**

Zhang Kai and Gong Liutang

In order to analysis the multiplier effect of government consumption and investment under different exchange rate system, we build a two-sector DSGE model including trade sector and non-trade sector. Meanwhile, input and output network is taken into consideration for depicting the linkage of sectors elaborately. Through parameter calibration and simulation, we get some results worth noted. First, introducing input and output network would lead to sector co-movement and fiscal expansion acceleration which would make government multiplier larger than one. Second, under fix exchange rate, government spending multiplier will be larger. Third, the multiplier effect of non-trade sector is much larger than trade sector. Fourth, the multiplier effect of government investment is more obvious and endurable than government consumption.

##### **Liabilities of Foreignness: Theoretical Extension and Empirical Examination**

According to traditional theories, the inward internationalization, i.e. emerging markets firms (EMFs) collaborate with foreign MNCs in home countries before entering overseas markets, is beneficial to EMFs’ following international expansion. However, researchers gradually realize that it is not always the case. Although the collaboration with foreign MNCs contributes to the accumulation of international experience and knowledge for EMFs, EMFs can also suffer from liabilities in this process, which in turn will affect the level of outward internationalization. In view of this, by distinguishing the dimensions of time and space, this paper tries to extend the theory of liabilities of foreignness, and put forward the concept, pre-entry perceived foreignness (PEPF), which happens in the process of inward internationalization before emerging market small-sized and medium-sized enterprises (EM SMEs) enter overseas markets. This paper then investigates the relationship between inward international experience, PEPF and entry mode, as well as the mediating effects of PEPF between inward international experience and entry mode. By empirical examination on 144 China’s SMEs, it is concluded that: First, collaborative time has positive effects on PEPF; Second, the longer the collaborative time is, the lower the entry mode SMEs will choose; Third, PEPF wholly mediates the relationship between collaborative time and entry mode. This paper therefore emphasizes the ignored problems of PEPF in inward internationalization and provides a new perspective for the relationship between inward and outward internationalization.
