#### ABSTRACTS OF SELECTED ARTICLES

#### Use the New Development Pattern Theory to Guide Economic Work in the New Stage of Development

Ma Jiantang and Zhao Changwen

Accelerating the construction of a new development pattern, with the domestic cycle as the main body and the domestic and international dual circulations that complement each other, is the major strategic decisions made by the Central Committee of the Communist Party of China with Comrade Xi Jinping at its core in accordance with the changes of our country's development stage, environment, and conditions. It is the inevitable choice to implement the new development concept and firmly promote the high-quality economic development in the new development stage. It is the only way to coordinate development and safety and achieve safer development in the new development environment. It is a fundamental measure to cultivate new growth drivers and reshape competitive advantages under new development conditions. The theory of the new development pattern has rich scientific connotations, and it is the latest achievement of Xi Jinping's Thought on Socialism with Chinese Characteristics for a New Era, which is the persistence, deepening and expansion of the new development concept and overall national security concept. The theory of new development pattern emphasizes the use of domestic super-large-scale market advantages and the potential of domestic demand, and emphasizes the fundamental driving force of deeper reforms, higher levels of openness, and higher quality innovation, which provides fundamental following and action guidelines for the overall planning of the great rejuvenation strategy of Chinese nation and major changes unseen in the world in a century, planning and carrying out the "14th Five-Year Plan" and the economic work for a period time in the future to come.

#### Digital Economy, Technology Spillover and Dynamic Coopetition Policy

Xu Heng, Zhang Yilin and Cao Yujia

Based on the game model of asymmetric competition between the digital economy (enterprise) and the traditional economy (enterprise), this article investigates the two kinds of effect that the digital economy has on the traditional economy—technological spillover and technological impact: on the one hand, in the early stage of the digital economy entering the market, the digital economy has a technological spillover effect on the traditional economy, which will help the latter to carry out digital transformation and upgrading. At the same time, both of them compete with each other, which will enhance the total social welfare. However, under the huge impact of disruptive innovation of the digital economy, the traditional economy may be squeezed out of the market before it has completed its transformation. Since then, the digital economy has gained market dominance and even monopoly position. In addition, the strong network effect and the feature of marginal cost close to zero of the digital economy have made it difficult for
