**Institutional Logic and Major Contribution of Centennial Land Policy to Political Order,
Economic Development and National Governance**

Qu Futian, Ma Xianlei and Guo Guancheng

Throughout the Centennial land policy practice of the Communist Party of China, it presents a process of exploration, establishment, reform, development, continuous maturity and improvement, and finally forms a socialist land policy system with Chinese characteristics. Based on the recognition that land policy is the bottom logic of national development, this paper systematically analyzes the great contribution and institutional logic of the party's Centennial land policy practice from three dimensions of political order, economic development and national governance by using the analytical framework of "policy change-behavior mechanism-path response" and fully reveals the great role played by the land policy in realizing the party's first Centennial goal. With the Sinicization of Marxist land thought, the Centennial practice of land policy has also accumulated important experience for realizing the party's second Centennial goal. Based on the results above, the future land policy needs to actively respond to the new proposition put forward by the modernization construction in the new era, and make active exploration and effective changes in the land property right structure, urban-rural land relations, spatial governance system, overall development and security.

**Measurement of Domestic and International Double Cycle of China's Economy:
The Essential Characteristics of the New Development Pattern**

Huang Qunhui and Ni Hongfu

This paper expounds the "new development pattern" from the perspective of the conceptual logic of economic cycle, then constructs the international and domestic cycle measurement index from both the supply and demand sides and a new method of domestic and international cycle GDP decomposition based on the global value chain, and makes an empirical calculation with WIOD data. On this basis, the paper gives an deep analysis of the essential characteristics of the new development pattern. Results show that: whether from the perspective of domestic final demand rate of final products or the perspective of domestic supply rate of intermediate products, indicators show that the degree of China's domestic economic cycle contributes about 90%. From the perspective of international comparison, China ranks fifth in the proportion of GDP relying on domestic cycle, which shows that the dominant position of domestic economic cycle is basically established if only based on the new economic flow of domestic and international economic cycle. However, it cannot be considered that the new development pattern has basically taken shape. The key connotation of the new development pattern is to smooth the economic cycle, and the essential feature is to achieve high-level self-reliance and self-improvement. The new development pattern is not only reflected in the high proportion of China's domestic circular flow in the overall economic cycle, or that China's GDP growth mainly depends on the domestic economic cycle, but also reflected in the unimpeded economic cycle driven by domestic high-level independent innovation, and the continuous expansion of domestic demand playing the leading role of domestic
