## “社会治理视域下深化公安警务机制改革研讨会”在我院召开

6月21日,由湖北警官学院和湖北省公安厅研究室主办,治安管理和襄阳市公安局承办的“社会治理视域下深化公安警务机制改革研讨会”在湖北警官学院北院教研楼三楼会议室召开。公安部改革办副主任赵炜、处长丁国强和部分公安机关、公安院校的领导和专家、学者、教师70余人参加了研讨会。学院党委书记、院长曹诗权,院党委委员、副院长刘光明,学院党委委员、纪委书记汪家广出席研讨会。

在上午举行的开幕式上,曹诗权同志致开幕辞。他指出,学院和省公安厅研究室、襄阳市公安局联合召开“社会治理视域下深化公安警务机制改革研讨会”是学院教学单位和公安机关实战部门深度融合、协同创新的有益尝试,是实践科研转型服务、彰显学院智库功能的积极行动。通过深化公安警务机制改革研讨会,促使公安机关和民警更加适应新一轮司法体制改革的一系列要求,从而进一步推动社会治理现代化。警务机制改革只有进行时没有完成时,希望此次研讨会能够进一步开启各位同仁的思路,开启管道,启发思维,奉献成果。

赵炜同志就警务机制改革发表了讲话。他指出,“社会治理视域下深化公安警务机制改革研讨会”是党的十八届三中全会通过的《中共中央关于全面深化改革若干重大问题的决定》、公安部成立改革办后全国召开的第一次研讨会,意义深远,影响力大,说明湖北警官学院教学、科研工作紧密围绕党的中心工作和公安中心进行研究,站位高,立意新,动作快,走在全国的前列,居于领先地位。他从“为什么改——警务机制改革的必要性”、“改成什么样——警务机制改革的前景展望”、“如何改——警务机制改革如何进行”三个方面发表了意见。

开幕式结束后,大庆市公安局、黄石市公安局、新乡市公安局、武汉市公安局、襄阳市公安局分别介绍了各自的警务机制改革情况。武汉市公安局介绍了立体化社会治安防控体系构建情况。与会代表对以上公安机关警务机制改革情况和立体化社会治安防控体系构建进行了深入地研讨。
