Look Forward to 2011

The Five-Year Plans of People's Republic of China (PRC) are a series of economic development initiatives. The economy was shaped by the Communist Party of China (CPC) through the plenary sessions of the Central Committee and national congresses. The Twelfth Five-Year Plan was debated in mid-October 2010 at the fifth plenary session of the 17th Central Committee of the Communist Party of China (CPC), the same session in which Xi Jinping was selected as Vice Chairman of the Central Military Commission. A full proposal for the plan was released following the plenum and is subject to approval by the National People's Congress during its annual session to be convened in the first quarter of 2011. The Twelfth Five-Year Plan seeks to address rising inequality and create an environment for more sustainable growth by prioritizing more equitable wealth distribution, increased domestic consumption, and improved social infrastructure and social safety nets. The plan is representative of China's efforts to rebalance its economy, shifting emphasis from investment toward consumption and from urban and coastal growth toward rural and inland development. The plan also continues to advocate objectives set out in the Eleventh Five-Year Plan to enhance environmental protection, accelerate the process of opening and reform, and emphasize Hong Kong's role as a center of international finance.

2011 Looking Good with Revenue Growth of 5.6%

Economic growth in the United States will continue in 2011, according to a report released on Dec. 7 by the Institute for Supply Management. Expectations are for a continuation of the economic recovery that began in mid-2009 with business investment increasing substantially.

Expectations for 2011 are positive as 65% of survey respondents expect revenues to be greater in 2011 than in 2010. The panel of purchasing and supply executives expects a 5.6% net increase in overall revenues for 2011, compared to a 7.9% increase reported for 2010.

Biz Frontier P80

Step Into Changzhou, Showing Liugong Speed

A new excavator manufacturing and R&D facility of Liugong is under construction in Changzhou, Jiangsu Province. The factory investment, ¥1.5 Billion (€161 million, US\$225 million) represents the largest investment Liugong has ever made outside its headquarters of Liuzhou. A groundbreaking ceremony was held in June for the facility and construction is currently underway. The plant, which includes both the new manufacturing floor and a new R&D base, is 140,946 square meters. When completed in December of 2011 the new factory will employ 1,200 people and initial capacity will be 10,000 excavators per year.
