Abstract: The application platform sharing system is an important profit-making way for application platform enterprises. With the help of the dual standard of "behavior-ability" and the description of the subject theory in the normative theory of economic law, it can be explained from the perspective of jurisprudence how the application platform as the receptor of regulation has regulation ability. The purpose of regulating the application platform sharing system by economic law is not only to ensure full competition in the market and maintain the order and efficiency of the market economy, but also to guide the public regulation ability of the application platform to become a major boost to the economic law supervision system. Economic law regulation can be put forward from the following aspects: constructing the relationship between the application platform and the administrative supervision system, introducing compliance system to protect the rights and interests of all parties in the application platform, and limiting the maximum share ratio.

Abstract: Land acquisition and demolition in the process of urbanization constitute the field of interest game among all the stakeholders, and the land transfer income under the urban-rural dual system further aggravates the complexity of the game. Based on the investigation of the practice of land acquisition and demolition in Q District of N City, this paper puts forward the viewpoint of win-win benefit sharing and its preliminary analysis framework. It aims to solve the problems of "where the profit comes from", "who participates in sharing" and "how to share". Among them, the "profit" of benefit sharing comes from land transfer income and land acquisition compensation; participants include the central government, local governments, village collective economic organizations or village committees, land-lost farmers and developers; the path of benefit sharing depends on the construction of systems, the participation of land-lost farmers, the coordination among subjects, the innovation of sharing methods and the establishment of supervision system. In this process, we should also pay attention to and properly solve

the possible "unexpected consequences".

**Online Public Opinion under the Background of Covid-19 Epidemic:

Abstract: With the domestic epidemic prevention and control entering the normalization stage, the main public opinion about Covid-19 epidemic is relatively stable. In addition to the unremitting efforts to prevent and control the epidemic situation, the country should pay attention to the monitoring and prevention of secondary public opinion and other public opinions. The existing researches mainly focus on the background, formation mechanism and guidance of online public opinion, while there is little systematic exploration of the social implication of online public opinion. It is found that the Covid-19 epidemic has a profound impact on the social life order of human beings, and the secondary public opinion and other major public opinions in this context are not simple anymore, which indicates that the more common and deeper social problems in the context of China's rapid social changes have been awakened. When interpreting why specific events have aroused widespread concern on the Internet, we need to explore practical social problems such as social and cultural mentality, inter-group discrimination, cyber violence and so on, which are caused by the structural forces behind public opinion. In view of this, only by targeting the prominent social problems behind public opinion can we truly apply the precise policy to deal with public opinion, and then provide scientific basis for the source governance of online public opinion.

Abstract: It is a great reform of rural community-level governance system to comprehensively promote the "concurrent post holding"(yijiantiao) of village-level organization leaders. On the basis of sorting out the research context and policy evolution of the yijiantiao practice, this paper analyzes the differential implementation mechanism of the yijiantiao practice combined with local policy experiences. Its effect is analyzed from four dimensions: political leadership ability, organizational unity ability, village-level governance ability and social mobilization ability. Comprehensively promoting the yijiantiao practice of village leaders is helpful to enhance the Party's political leadership ability in rural society, while whether it can enhance organizational unity, village-level governance and social mobilization is uncertain.
