This paper analyzes current land grant system in transition development from three perspectives including local financial system, role of land policy in macro-control and property law framework. The results indicate that land grant system has three functions including financial revenue, macro-control and property right, which are embedded in the framework of land public-ownership. Despite of the negative effects of land grant system, we should continue to insist on the institutional framework that municipal or county governments are responsible for state-owned land grant. Under this premise, we should strengthen its role as the foundation of land usufruct rights system with Chinese characteristic, improve and refine their financial and regulatory functions.

Institutional Efficiency, Group Consensus and the Innovation of Rural Land Institution

Institutional efficiency is the concept which is well connected with the actual institutional circumstances. It is the feasible path to constitute the fair mechanism of rural land rights under a steady constitutional order. We should figure out that group consensus function significantly among the informal constraints which affect the innovation of rural land institution. It's the feasible means currently to establish and perfect the self-governance of villagers to guarantee and implement the rights of rural land, and the foundation is the reconstitution and transformation of group consensus for self-governance of villagers.

The rural finance has strong positive externality. In the process of incentive positive externality of the rural financial, Economic law follow the basic principles of the efficiency and competitive priority, distinguish different financial nature and need appropriate intervention of the state, with the value goal of the essence fair, economic benefit and sus-

tainable development of the rural financial ,mainly from perfecting the legal system of rural financial and formulating the supporting legal system of rural financial to incentive the positive externality of Rural financial in order to promote the healthy development of rural finance.

To Speed up Rural Financial Service Innovation and Promote the Coordinated Development of Urban and Rural Economy:Takes Chongqing, the Urban and Rural Comprehensive Reform Areas as an Example WEN Tao(34)

Rural economic development is inseparable from the support of rural finance. However, at the present time, financial services in our country can't meet the needs of the new socialist rural construction and the urban and rural development. Therefore, this paper takes Chongqing as an example, and deeply reveals the main obstacles, which rural financial service faces, under the conditions of market economy. Then we point out the service innovation and system design in order to provide theoretical and policy support for further deepening rural financial system reform, carrying out the 3.14 overall arrangement efficiently and forming new pattern about the integration of urban and rural economic and social development.

The designing for new rural social pension insurance system, the new rural cooperative healthcare system and minimum living guarantee system has been done, with great improvements in relevant areas, whereas, the disparity between rural and urban is still obvious. Under the different security conditions and at different expenditure levels, financial budget plans should vary along with the rural social security undertakings. Based on the estimation of the future government revenue, the authors take that if only the government function could be transformed with the establishment of public finance, it's feasible within the future financial capacity of the government to implement a high level budget solution with a full coverage of rural social security programs.

Analysis on Major Illness Risk and the Economic Costs for Farmers in Poor Areas CHEN Yuping(67)

This paper explored households' perception on major illness and its impact in poor rural areas, investigated occurrence of major illness and estimated economic costs of households. The paper found that rural residents perceived major illness mainly from the perspectives of treatment methods, costs, severity of the illness, and levels of healthcare providers. Economic cost of major illness was generally estimated beyond 8000 RMB Yuan per year; the poor households faced greater risk and higher costs of suffering major illness. The paper suggested that the New Cooperative Medical Scheme should include reimbursement of chronic illness treatment, government should encourage community-based and market-based health care services; special financial service should be provided to the poor households and the current Medical Financial Assistance scheme should be further improved.
