The Study on the Gender Wage Differential among Rural-urban Migrant HUANG Zhiling (44)
Using CHIP2002 rural migrant data implemented by the institute of economics, CASS., this arti-

cle explores the reasons for the gender wage differential among rural-urban migrant with Brown model. Excluding personal endowment differences, there are still 80.7 percent can not be explained by differences in individual characteristics of the discriminatory part. Our findings indicate; in addition to administrative and legal means to eliminate gender discrimination to narrow the gender wage gap among rural-urban migrant, improving the education level of rural women is also an important factor. A comparison with another study on China's urban labor market is made, which suggest that competitive market forces deteriorate the gender discrimination to some extent.

#### The Institutional Constraints and Optimization Design of the Village Banks

With the incremental reform of rural finance as the background, this paper studies the fundamental state and practice effect of village banks. A profound discussion is then conducted on a series of institutional constraints imposed on the further development for village banks, including simple mix and demanding requirements of sponsoring agencies as well as incompleteness of the basic system and supporting policies. Suggestions for improvement of village banks are finally proposed in the paper.

This paper focusing on the issue of farmers' breach of contract in the based on the theory of development finance provides a new micro-credit pattern which is based on the theory of the development of financial. Dynamic game model analysis showed that under the guidance of the theory of the development of financial we can solve the problem of Farmers' Moral Risk. At last, we make recommendations for micro-credit in China with government policies.

Trade Index in Dynamic Industry ...... ZHANG Ping, WU Hong and ZHOU Qi(76)

In recent years, domestic and international public crisis happen frequently, and bring great harm, so the public crisis management studies become a hot academic topic. But the public crisis management studies in China show the non-equilibrium situation of "focusing on the urban, ignoring the rural". China's rural public crisis management studies begin from the 21st century, so the relevant research results are still very few. With the emerging of global risk situations, strengthening studies on rural public crisis management is becoming very urgent. In this paper, the author puts out that several key issues a-

bout the rural public crisis management process and study method and on this basis he proposes a new theoretic analysis framework on the studies for rural public crisis management.

#### Potential Assessment of Participating Carbon Trade for Chinese Agriculture Green House

Gas (GHG) Emission in International Market ...... HUANG Delin and CAI Songfeng (89)

As for the research of reduction of Chinese agricultural greenhouse gas emissions, carbon trading which belong to Tokyo Protocol is introduced as a method to governance GHG. Agricultural greenhouse gas emissions will be integrated into the international emissions trading market, providing a way to reduce emissions of GHG, In order to theoretically explore the feasibility of this study, fist, established theoretical model of international emissions, the absolute and Intensity control was defined to analyze the role of countries played in international emissions market. As a result, intensive control is more likely to become suppliers in international emissions market, however, The result depends on the relative value between degree of the intensity emission and intensity control, If the level of intensity control emission is lower than the level of intensity emission of this country, the country will become suppliers in international emissions market. In order to verify conclusions, GTAP-E model with the data of Chinese greenhouse gas emission is used to evaluate the potential of Chinese agriculture green house emission in participating carbon trade in international market, finally the theoretical conclusions is validated.

#### The Special Problems Discussion of Evolution Path in Marine Industry

By summing up the performance of the special problems of evolution path in marine industry, the reach conclusion is that traditional path of evolution of three industries do not apply to the marine industry, and the reasons for such non-applicability is analyzed. And thus should explore the unique evolution path of marine industry by establishing analysis matrix on two aspects of degree of difficulty and urgency. Lastly, point out relevant policy priorities for different management types of marine industry.
