The research of the farmers act to animal disease based on the analysis of game theory, under the major animal plague crisis

..... LUO Li , LIU Fang , HE Zhongwei (56)

The motivation, which forces farmers take action to prevent and control animal disease, can be divided into three aspects: firstly, the pursuit of self-interest maximization; secondly the health principal-agent relationship between the consumers; and thirdly the government's mandatory regulation. Under the risk of major animal epidemic crisis, this paper analyze the position of three subjects in crisis system, and studies the influence of the interaction mechanism between the main body.

Study on the impact of the rural labor migration upon fertilizer pollution in China

..... LUAN Jiang , LI Tingting , MA Kai (63)

In this paper, we examine a possible causal link between China's massive rural labor to urban migration and high chemical fertilizer use rates over the past 30 years. The empirical results show that there is a positive correlation between labor out-migration and fertilizer use per hectare. Along with the large-scale rural labor force shift, the intensity of fertilizer use subsequently increases. The growth of non-farming incomes and the change of agriculture planting structure lead to high fertilizer use rate, while the large-scale management of land will help reduce fertilizer use intensity.

The development of the international wine market and its influence on China

Economic globalization is changing the international wine industry resources and market distribution, and the Old and New World's pattern of international wine industry has formed. This paper based on the Old and New World's pattern of the international wine industry, analyzes the international wine market development elements such as the world grape cultivation and production, the production and export trade, the world wine consumption and import trade, and puts forward the effects of the international wine market development on wine industry of China.
