A Century's Evolution of Modern Western Philosophy of Language and Its New Trend: The Turn from the Conception of Modern Philosophy of Language to the Conception of Postmodern Philosophy of Language TONG Li

Abstract: The trend of thought in western philosophy of language is the product of both natural science revolution and anti-metaphysics since the beginning of 20th century. Not only does modern philosophy of language emphasize that philosophical research should take scientific research as the paradigm, but also it applies scientific methodology, attaches importance to analyse the meaning of language, pursues the logic of language, clarifies the fuzziness and meaningfulness of language, and opposes abstract speculative metaphysics and even grand narrative research. The turn from the conception of modern philosophy of language to the conception of postmodern philosophy of language proclaims a new direction of contemporary western philosophy of language. Having inherited the anti-metaphysics tradition of modern philosophy of language, postmodern philosophy of language highlights the features of negativity, edification and constructiveness. In particular, the constructive Posties theory and the current ecological trend of thought reach the same goals by different means to promote the global spread of

Wittgenstein on Phenomenological Language of Colour

Abstract: As a result of the analytic a priori hypothesis, the Tractatus Logico-Philosophicus system can not handle the colour incompatibility problem. Wittgenstein startes his short phenomenological phrase and tries to construct a

phenomenological language of colour, which can be used to assert analytic a posteriori judgement to complemen Tractatus Logico-Philosophicus system. However, Wittgenstein finally realizes that phenomenology is grammar, and begins to evolve his thought. In Remarks on Colour 20 years later, Wittgenstein exposes that there is no phenomenology and the research on phenomenological problems is a kind of conceptual analysis and a part of the research on actual usage of language. The conceptual analysis of actual use of language is a necessary element in the construction of any ideal language.

On J. L. Austin's Linguistic Phenomenology as a Philosophical Method YANG Yu-cheng

Abstract: J. L. Austin's linguistic phenomenology as a philosophical method mainly deals with or resolves some traditional philosophical problems through careful research on the use of specific terms. Austin defends and elaborates on the practical operation steps of this method of linguistic phenomenology in the paper "A Plea for Excuses". Although Austin's works are difficult to translate, his fine language research methods can be used for learning and applied in another language background. This method may be a feasible way to clarify some basic concepts of Chinese philosophy.

Hilary Putnam on Conceptual Relativity

SHEN Xue-fu

Abstract: Starting from Hilary Putnam's cognitive equivalence, which he put forward in order to elucidate meaning and truth in the early years, this paper analyses the doctrine of conceptual relativity in his philosophy of language. He starts his philosophical career on a scientific realist position which sticks to metaphysical realism and acknowledges that there is a complete and real description of the world. In his late philosophy, Putnam advocates pragmatic pluralism and regards that the theories and ways of describing the world demonstrate a kind of plurality. Conceptual relativity acknowledges that there are different equivalent and contradicted descriptions of the same phenomenon. However, the conceptual schemes of Putnam and Davidson cannot be confused, since the former is used to investigate conceptual relativity. Deeply influenced by late Wittgenstein, Putnam advocates pragmatic pluralism in his later philosophy through questioning truth monism. It is necessary for him to go back to the philosophical tradition of American pragmatism.

Abstract: Philip Roth's The Human Stain tells about Professor Coleman Silk's fight against the unfair charge of racial discrimination and his striving life with concealed identity of black. From the perspective of discourse construction, various types of discourse compose the narrative context, and the literary discourse is constructed by the fusion of horizons. From the perspective of textual construction, the literary discourse is oriented and expanded by the structural variations of white/spook as an identity symbol. Abstract: The Giver by American writer Lois Lowry depicts a modern teenager's difficult journey of home building with knowledge and expresses Lowry's concern with the politics of home. The imagery of apples, rivers and snowflakes in the novel are invested with emancipatory discourse meanings to collectively harbor Lowry's hopes for teenagers' rebuilding modern home. Based on the novel's textual and historical contexts, this paper makes a literary discourse analysis of the key imagery in the novel to reveal Jonas' spiritual journey from understanding home to leaving home and finally to rebuilding home.

Metaphorical Discourse Narrative in Doris Lessing's Documents Relating to the Sentimental Agents in the Volyen Empire

Abstract: Based on a close reading of the text combined with a view of its historical and social background, this paper uses contemporary metaphor theories to make a comprehensive analysis of the language motif of Documents Relating to the Sentimental Agents in the Volyen Empire, a space fiction by the British Nobel Prize writer Doris Lessing, with an aim of revealing its metaphorical discourse narrative features. This novel is the final work of her sci-fi space fiction pentalogy Canopus in Argos: Archives. Starting from linguistic issues, the work concludes and sublimates the whole series. The hospital for rhetoric disease in the work functions to diagnose and treat various types of linguistic diseases that make people out of touch with practical experience, and thus to reveal the metaphorical essence of discourse and the empirical feature of human cognition. The decline history of colonial empires deeply brands Lessing's works to promote her thinking over the relationship between language, cognition and empirical reality. The work demonstrates a distinctive feature of self-referentiality and cognition to represent a new type of Utopian fable in sci-fi work.

These disagreements exist not only in the Chinese academic circles, but also in different English versions. Due to the different concepts of genre and cultural backgrounds, the translators have different understandings of content and different preferences of genre and approach.

Abstract: Translation discourse is the translator's way of speaking to reflect on, interpret and describe his translation activities. Chinese translation discourse traditionally exists in the form of paratext to determine the acceptability, dissemination and consumption of the text it reinforces. Lin Yutang's paratexts are imbued with translation discourse with strong Chinese characteristics. His special insights into translation covers most of the important issues in the field, ranging from the nature of translation, standards, strategies to principles, mental process and ethics of translation. Due to his translation discourse in the form of paratext, the interactive relationships between paratexts, and between the main texts and paratexts can be revealed so as to deeply understand his translation thoughts.

On Paratexts in the Translation of Dual-non Texts Based on English Translation of Chinese Culture-loaded Materials

Abstract: Most of the translation-oriented research on paratext in China choose officially published literary texts as the object. There is few research on the paratextual components of non-formally-published non-literary texts (dual-non texts) in the process of translation. Based on the English translation of Chinese culture-loaded materials, this paper explores the attributes, forms and functions of the three common types of paratextual components, namely the translator-friendly glossary, reader-friendly in-text notes and client-friendly typesetting format in the translation of dual-non texts, and concludes the common characteristics of paratextual components to be strong in timeliness, various in form and multiple in function, so as to enrich the existing paratext-related research in translation studies.

Paratext-based Reconstruction of Chinese Translation Discourse from 1949 to 1966 GENG Qiang

Abstract: This paper explores the role of paratext in the construction of Chinese translation discourse from 1949 to 1966, and reviews the translation theories of spiritual resemblance and the ultimate of transmutation through an analysis of the preface and afterword of Chinese translation of British literature. The preface and afterword of translation in this period are primarily written by the publisher and translator, who play the role of gatekeeper to educate and guide Chinese readers to interpret the translated literary works according to the political discourse. The translator is also the authoritative critics. The ideal translation standard is fidelity, smoothness, conciseness and simplicity. As an organic component of the dominant political discourse, the nonautonomous translation discourse in this period has been deeply influenced by the Communist Party's routes, guidelines and policies concerning literature and art. Translation is used to debunk the enemy, educate the people and strengthen the dominant ideology. It is not a pure language game at all, but a powerful political weapon in defense of ideology. Translation discourse is discarded shortly after China's reform. The domestic academia chooses to walk away from ideological criticism to aesthetics and science. The theories of spiritual resemblance and the ultimate of transmutation are the representative translation discourse in this period.
