Among his books are *Fiction and Repetition: Seven English Novels*, *Hawthorne & History: Defacing It*, *Theory Now and Then* and *Literature as Conduct: Speech Acts in Henry James*.



Bruce Robbins is Old Dominion Foundation Professor at Columbia University, specializes in fiction, transnational literature, literary and cultural theory, and postcolonial studies. He is not only the author but also the editor of many important books and articles on fiction, literary and cultural theories and postcolonial studies. His most recent book is *Perpetual War: Cosmopolitanism from the Viewpoint of Violence*.



James Simpson is Donald P. and Katherine B. Loker Professor of English at Harvard University. His books include *Sciences and the Self in Medieval Poetry: Reform and Cultural Revolution*, being volume 2 in the *Oxford English Literary History* (winner of the British Academy Sir Israel Gollancz Prize, 2007); *Burning to Read: English Fundamentalism and Its Reformation Opponents* and *Under the Hammer: Iconoclasm in the Anglo-American Tradition*.
